

Celebration Fall Classic Horse Show

October 31 - November 2, 2024 • Cooper Steel Arena

Online entries will be available starting October 27, 2024 through 1:00 pm each day of the show.
All other entries will be taken at the Show Office Inside Cooper Steel Arena from
3:00 to 6:30 PM each evening.

*Entry deadline for the first four classes is 5:00 PM each evening of the show.
All other entries must be made by 6:30 pm each evening.*

The 2024 Celebration Fall Classic will follow the rules and regulations of SHOW, Inc. and the Tennessee Walking Horse National Celebration®

- **SHOW, Inc. requires all entry sheets to contain the following information before a DQP will inspect an entry:** 1. Horse's official name and registration number 2. Trainer's name, complete address and license number 3. Exhibitor's name and complete address 4. Owner's name and complete address. **All padded entries will be subject to a \$30 per entry inspection fee. All Flat Shod entries will be subject to a one-time per show inspection fee of \$30 per entry and an additional \$5.00 per entry inspection fee.**
- ALL HORSES OVER SIX MONTHS OF AGE MUST HAVE A NEGATIVE COGGINS TEST WITHIN THE LAST 12 MONTHS TO BE ON THE CELEBRATION GROUNDS. COGGINS TEST CERTIFICATES SHOULD ACCOMPANY THE VEHICLE TRANSPORTING HORSES. **Anyone found in violation will be cited, fined, and instructed to remove the horse from the Celebration grounds by the Tennessee Department of Agriculture personnel. The minimum fine in Bedford County is \$150.00. In addition, ALL OUT-OF-STATE HORSES MUST BE ACCOMPANIED BY AN OFFICIAL HEALTH CERTIFICATE OR EQUINE INTERSTATE EVENT PERMIT (EQUINE PASSPORT) OBTAINED WITHIN 30 DAYS OF THE EVENT AS STATED BY THE TENNESSEE DEPARTMENT OF AGRICULTURE.**
- **There will be NO REFUNDS on entries and stalls.**
- **Under Tennessee State Law, an equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities.**
- **All Riders Cup Classes are Triple Points.**

SHOW FEES

GROUND FEE - \$30 per horse, INCLUDES ONE STALL

INSPECTION FEE - \$30 per entry

All Flat Shod entries are charged an initial \$30 Inspection Fee for the first entry of a horse and \$5 for each subsequent entry of that horse.

EXHIBITOR PARKING PASS - \$25 per show or \$20 for Thursday & Friday or \$10.00 per night. Includes tax (all vehicles except trucks pulling trailers will require an Exhibitors Pass to enter Gate A. Passes can be purchased at Gate A.

SHAVINGS - \$7.50 per bag

GOLF CART PASS - \$15.00, includes tax
(proof of liability insurance required)

RV PARK SPACE - \$50.00 per night, includes tax
